

# ◆ Nation of Gods' Covenant ◆

## Preamble

We, the living men and women — Divine Beings from all nations of the Earth — in pursuit of **wisdom, education, peace, joy, conscious living, freedom, empowerment, and self-realization**, do unite under the **Golden Sun of Truth**.

By **free will and divine sovereignty**, we establish this Covenant to guide our Nation for present and future generations.

We affirm that the **Nation of Gods** exists as a **private, spiritual, and sovereign nation** under **Divine Law, Natural Law, and the Covenant of Truth**, independent from all man-made jurisdictions and commercial constructs.


## Article I – Identity of the Nation

1. The name of this Nation shall be **Nation of Gods**.
2. The Motto of the Nation shall be: **Wisdom and Empowerment**.
3. The National Symbol shall be the **Golden Sun**, representing enlightenment, unity, and divine illumination.
4. The National Flag shall be a **white field with the Golden Sun** at its center, bordered in gold and inscribed with the words **NATION OF GODS**.

## Article II – Nature and Jurisdiction of the Nation

1. The **Nation of Gods** is a **non-territorial sovereign nation** existing wherever its Ambassadors and Nationals dwell.
2. The Nation exists in the **Private Domain** and operates under the following **jurisdictions of authority**:
  - **Divine Law** – the supreme law of creation, flowing from the Source of all being.
  - **Natural Law** – the immutable laws of life, truth, conscience, and cause and effect.
  - **Universal Law** – the harmonious principles that govern balance and interconnection among all living systems.
  - **Treaty Law** – recognized principles of peaceful relations and good faith between nations, peoples, and assemblies.
  - **Private Contract Law** – the right of private men and women to associate, covenant, and self-govern by mutual consent.

3. The Nation of Gods **does not operate under** or submit to:
- **Statutory, Admiralty, or Maritime jurisdictions;**
  - **Corporate governments** and their sub-entities, including but not limited to the **United States, Commonwealth of Australia, the Crown Corporation,** or any other **Cartel States** operating as legal fictions;
  - **Commercial, banking, or ecclesiastical systems** that impose upon the free will of Divine Beings.
4. The Nation stands **above and beyond commercial fictions**, remaining neutral in all worldly conflicts and refusing participation in violence or coercion.
5. No law or claim of any external authority may supersede the Divine and Natural Law upon which this Nation stands.
6. The Nation of Gods is eternal in spirit and cannot be dissolved, annexed, or claimed by any external force.

### Article III – Purpose of the Nation

The purpose of the Nation of Gods is:

1. To bring **wisdom and education** to all peoples.
2. To spread **peace, joy, and conscious living**.
3. To protect and advance the **freedoms and divine rights** of all who align with its Covenant.
4. To foster **empowerment and self-realization** as the highest forms of sovereignty.
5. To act as **Ambassadors of Light**, building bridges of friendship among nations and communities.
6. To uphold truth and stand as a living example of divine order and harmony among all Beings.

### Article IV – Governance

1. The supreme servant of the Nation is the **Head Ambassador**, entrusted with upholding the Covenant and representing the Nation internationally.
2. A **Council of Ambassadors** shall support the Head Ambassador and assist in decisions concerning the Nation's spiritual, diplomatic, and administrative affairs.
3. Departments may be established to serve the Nation's mission, including but not limited to:
  - Department of Peace & Cultural Affairs
  - Department of Education & Wisdom



- Department of International Relations
  - Department of Identity & Documentation
  - Department of Healing & Conscious Development
- 4.All governance shall be conducted with **honor, transparency, and service** to the Covenant and the Divine Will.
  - 5.No officer or Ambassador may act in personal interest contrary to the Covenant or the Nation's spiritual jurisdiction.

## Article V – Membership & Allegiance

- 1.Any living man or woman may become a **National of the Nation of Gods** by freely taking the **Oath of Allegiance** and making the **Sacred Contribution** of AU \$77.
- 2.Those who accept greater responsibility in service may be appointed as **Ambassadors** and may enter the **Covenant Path** with a **Sacred Contribution** of AU \$222.
- 3.Membership is **voluntary, private, and irrevocable**, except by free will.
- 4.All Nationals and Ambassadors are **equal in rights, dignity, and protection** under this Covenant.
- 5.No external power may interfere with or question the private affairs, declarations, or records of the Nation.

## Article VI – Rights & Duties

- 1.Every National shall enjoy full protection of their **Natural and Divine Rights** within the private domain of the Nation.
- 2.Every National shall have the right to **freedom of thought, speech, association, travel, and peaceful assembly**.
- 3.Every National shall uphold the Covenant by living in **truth, peace, respect, and honour** toward all Beings.
- 4.No National shall act in a manner that causes harm, deceit, or dishonour to another Being or to the Nation.
- 5.All Nationals have the duty to protect the sanctity and peace of the Nation and to live as examples of divine remembrance.

## Article VII – Relations with Other Nations

- 1.The **Nation of Gods** extends peace and recognition to all peoples, communities, and nations who respect sovereignty, conscience, and freedom.



2. Diplomatic relations may be established through **Letters of Recognition, Treaties, or Cultural Agreements**, based on mutual respect and non-interference.
3. The Nation shall never impose itself upon others, nor allow others to impose upon it, but will always act in good faith and lawful honour.

## **Article VIII – Continuity & Amendment**

1. This Covenant is **eternal in principle** and may only be amended by the **Council of Ambassadors** with the assent of the **Head Ambassador**.
2. Amendments must align with **Divine and Natural Law** and may not alter the spirit or sovereignty of the Nation.
3. The **Nation of Gods** shall endure as long as its people uphold its values and carry forth its light under the Golden Sun of Truth.
